I understand that it may be unsafe to play under the influence of alcohol and/or drugs and accept any and all liability for my actions. I understand that I must be 21 years old to consume alcohol in the state of Iowa. I understand that if I am allowed to bring alcoholic beverages onto Arnolds Park Amusement Park property, I must keep it strictly confined to the volleyball court area and that I am responsible for cleaning up after myself and my team. I understand that if I appear to be under the influence of drugs and/or alcohol, I may be forced to leave the premises immediately by my Captain and/or league organizers.
